Sub : Dr.YSRHU – Allowances – Dearness Allowance – Revision of rates of Dearness Allowance to State Government from 1<sup>st</sup> July, 2011 – Implementation in Dr.YSR HU – Orders – Issued.

Government in the reference 9<sup>th</sup> cited issued orders revising the rates of Dearness Allowance from 29.96 % to 35.952% of basic pay from 1<sup>st</sup> July, 2011 in respect of State Government Employees and be implemented to the Non teaching employees of Dr.YSR Horticultural University who are drawing Revised Pay Scales 2010 on par with the State Government employees and from 51% to 58% of the basic pay to Teaching employees who are drawing Revised U.G.C. Pay Scales, 2006 with effect from 1<sup>st</sup> July, 2011.

Government in the said G.O. has also issued orders that the revision of DA shall be applicable to Teaching and Non-teaching staff of Government and Aided Affiliated Degree Colleges who are drawing pay in the Revised U.G.C. Pay Scales, 2006. The Teaching staff of the Universities including the Acharya N.G. Ranga Agricultural University and the Jawaharlal Nehru Technological University and the Teaching staff of Govt. Polytechnics who are drawing pay in the Revised UGC/AICTE Pay Scales, 2006.

Government also issued orders that the revision of rates of Dearness Allowance in respect of State Government employees drawing the Revised U.G.C. Pay Scales, 1996, from 115% to 127% of the basic pay with effect from 1<sup>st</sup> July, 2011, as DA equivalent to 50% Basic Pay was already merged through G.O. Ms. No.9, Higher Education (U.E.I) Department, dated 08-02-2006 and G.O. (P) No. 173, Finance (PC.I) Department, dated 23-07-2007.

Government issued orders that the revision of rate of Dearness Allowance sanctioned to the State Government employees in the Andhra Pradesh Revised Pay Scales, 2005 from 99.852% of the basic pay to 111.156% of the basic pay with effect from 1<sup>st</sup> July, 2011 in the Revised Pay Scales of 2005.

Government issued orders that the revision of rate of Dearness Allowance sanctioned to the State Government employees in the Andhra Pradesh Revised Pay Scales, 1999 from 116.974% of the basic pay to 126.79% of the basic pay with effect from 1<sup>st</sup> July, 2011 in the Revised Pay Scales of 1999.

Government in the said G.O. cited has issued orders for payment of the Dearness Allowance shall be paid in cash from the month of November, 2011. The arrears on account of payment of Dearness Allowance for the period from 1<sup>st</sup> July, 2011 to 31<sup>st</sup> October, 2011 shall be credited to the General Provident Fund Account of the respective employees.

However, in case of employees who are due to retire before 1<sup>st</sup> June, 2012 the arrears of Dearness Allowance shall be drawn and paid in cash as the employee due to retire on superannuation is compulsorily exempted from making any subscription to the General Provident Fund during the last four months of service.

In case of employees who do not have General Provident Fund accounts, the arrears of Dearness Allowance for the period of 1<sup>st</sup> July, 2011 to 31<sup>st</sup> October 2011 shall be credited to Contributory Pension Scheme Account.

The Dearness Allowance shall be paid in cash with effect from 01-11-2011 and the arrears for the period from 01-07-2011 to 31-10-2011 shall be credited to the General Provident Fund Accounts of the respective employees.

Accordingly, sanction is hereby accorded for payment of revised DA rates as indicated in paras 1 to 9 above with effect from 01-07-2011 to the Teaching and Non Teaching employees of Dr. YSR Horticultural University respectively.

All the Drawing Officers and Assistant Comptroller are therefore requested to adhere to the above instructions scrupulously without any deviation.
