Government in the reference 10th cited issued orders have been issued revising the rates of Dearness Relief from 29.960 % to 35.952% of basic pay from 1st July, 2011 in respect of pensioners and be implemented to the Non teaching employees of Andhra Pradesh Horticultural University who are drawing Revised Pay Scales 2010 on par with the State Government employees and from 51% to 58% of the basic pay w.e.f 01-07-2011 to Teaching employees who are drawing Revised U.G.C. Pay Scales 2006.

Government issued orders that the revised Dearness Relief to

- (i) those who retired from service after 01-07-2008 and drawing pension in the Revised Pay Scales, 2010.
- (ii) those who retired prior to 01-07-2008 and whose pension was consolidated.
- (iii) those who retired prior to 01-01-1996 drawing UGC Pay Scales and whose pension was ordered to be consolidated in the light of orders issued in G.O. (P) No.95, Finance (Pen.I) Department, dated 01-08-2000 and
- (iv) the monetary benefit of Dearness Relief now sanctioned above shall be with effect from the month of July, 2011.

Government issued orders that the revision of rates of Dearness Relief from 99.852% to 111.156% with effect from 01-07-2011 to the Pensioners who are drawing their pension in Revised Pay Scales, 2005 and not consolidated in terms of the orders issued in G.O.Ms.No.100, Finance (Pen.I) Department, dated 06-04-2010.

Government issued orders that the revision of rates of Dearness Relief from 116.974% to 126.79% with effect from 01-07-2011 to the Pensioners who are drawing their pension in Revised Pay Scales, 1999 and not consolidated in terms of the orders issued in G.O. (P) No.248, Finance (Pen.I) Department, dated 04-10-2005.

Government issued orders that the revision of rates of Dearness Relief in respect of pensioners who retired after 1-1-1996 drawing UGC Pay Scales 1996 from 115% to 127% with effect from 01-07-2011 since the Dearness Relief was regulated upto 01-01-2007 by merging 50% Dearness Relief with basic pension through G.O (P) No.183 Finance (Pen.I) Department dated 02-08-2007 based on the orders issued in G.O. (P) No.173 Finance (PC.I) Department dated 23-07-2007.

The amount of Dearness Relief shall be rounded off to the next rupee. The arrears of the Revised Dearness Relief to Pensioners shall be paid along with the pension of February, 2012 payable in March, 2012.

In event of death of the pensioner after 01-07-2011 the arrears of Dearness Relief shall be paid to the legal heirs in lumpsum at a time duly following Treasury Procedure.

Hence, sanction is hereby accorded for payment of Dearness Relief to the pensioners with effect from 1st July, 2011.
