ORDER :

The Registrar, Dr.YSRHU in his letter read above has stated that Agri. & Coop. (Agri.III) Deptt.vide G.O.Ms.No.40, dt.10.4.2018 have accorded permission to ANGRAU for implementation of reservation under farmers quota of 40% seats for candidates of all social categories coming from families of farmers owning a minimum of one (1) acre of land instead of earlier 03 acres (three acres) either in the name of the parents or in the name of the candidates. Further the candidate should have studied for a minimum of 4 years in schools located in Non-Municipal areas for admission into UG programmes from the year 2018-19.

2. The Registrar, Dr.YSR Horticultural University has, therefore, to accord permission to implement the same criteria for B.Sc.(Hons.) Horticulture Programme in Dr.YSRHU pertaining to reservation under farmers quota of allotting 40% seats to candidates of all social categories hailing from families of farmers owning a minimum of one(1) acre of land instead of three (3) acres on par with ANGRAU w.e.f. the academic year 2018-19 onwards.

3. Government after careful examination of the matter hereby accord permission to implement the modified criteria of 40% of the seats in Dr.YSR Horticultural University reserved for candidates of all categories coming from families of farmers owning a minimum of (1) acre of land either in the name of the parents or in the name of the candidates and who have studied for a minimum of 4 years in the in schools located in Non-Municipal areas for admission into UG programmes from the year 2018-19.

4. The Registrar, Dr.YSR Horticultural University, Venkataramannagudem, W.G.dist. is requested to take necessary action accordingly.
