Sub: APHU - Allowances - Dearness Allowance-Revision of rates of DA to State Government from 1st January, 2011 - Implementation in APHU-Orders-Issued

Ref: 1. G.O. Ms.No. 104, dt 30-5-2011 of Finance (PC-I) Department, Govt of A.P.
2. Note orders dated 16-6-2011.

The Government in the said G.O. cited orders have been issued revising the rates of Dearness Allowance from 24.824 % to 29.96% of basic pay from 1st January, 2011 in respect of State Government Employees and be implemented to the Non teaching employees of Andhra Pradesh Horticultural University who are drawing Revised Pay Scales 2010 on par with the State Government employees and from 45% to 51% of the basic pay to Teaching employees who are drawing Revised U.G.C. Pay Scales, 2006 with effect from 1st January, 2011.

The Government in the said G.O. hereby order that the revision of DA as in Para 1 shall be applicable to Teaching and Non-teaching staff of Government and Aided Affiliated Degree Colleges who are drawing pay in the Revised U.G.C. Pay Scales, 2006. The Teaching staff of the Universities including the Acharya N.G Ranga Agricultural University and the Jawaharlal Nehru Technological University and the Teaching staff of Govt. Polytechnics who are drawing pay in the Revised UGC/AICTE Pay Scales, 2006.

Government also hereby order the revision of rates of Dearness Allowance in respect of State Government employees drawing the Revised U.G.C. Pay Scales, 1996, from 103% to 115% of the basic pay with effect from 1st January, 2011, as DA equivalent to 50% Basic Pay was already merged through G.O. Ms. No.9, Higher Education (U.E.I) Department, dated 8-2-2006 and G.O (P) No. 173, Finance (PCI) Department, dated 23-7-2007.

Government hereby order the revision of rate of Dearness Allowance sanctioned to the State Government employees in the Andhra Pradesh Revised Pay Scales, 2005 from 88.548% of the basic pay to 99.852% of the basic pay with effect from 1st January, 2011 in the Revised Pay Scales of 2005.

Government hereby order the revision of rate of Dearness Allowance sanctioned to the State Government employees in the Andhra Pradesh Revised Pay Scales, 1999 from 107.158% of the basic pay to 116.974% of the basic pay with effect from 1st January, 2011 in the Revised Pay Scales of 1999.

The Government in the said G.O. cited has issued orders for payment of enhanced Dearness Allowance in cash with the salary of May, 2011 payable in June, 2011. The arrears on account of payment of Dearness Allowance for the period from 1st January, 2011 to 30th April, 2011 shall be credited to General Provident Fund Account of the respective employees.

However, in case of employees who are due to retire before 1st October, 2011 the arrears of Dearness Allowance shall be drawn and paid in cash as the employee due to retire on superannuation is compulsorily exempted from making any subscription to the General Provident Fund during the last four months of service.

In case of employees who do not have General Provident Fund accounts, the arrears of Dearness Allowance for the period of 1st January, 2011 to 30th April, 2011 shall be credited to Contributory Pension Scheme Account.

P.T.O

The arrears for the period from 1-1-2011 to 30-4-2011 shall be credited to GPF account, a separate orders will be issued soon after the receipt of the Grant from the Government.

Accordingly, sanction is hereby accorded for payment of revised DA rates as indicated in Paras 1 to 9 above with effect from 1-5-2011 to the Teaching and Non teaching employees of Andhra Pradesh Horticultural University

All the Drawing Officers and Assistant Comptroller are therefore requested to adhere to the above instructions scrupulously without any deviation.
